Sir,

This has reference to NBA's letter of even number dated 11-04-2017 under which UG Pharmacy program offered by your Institution was granted accreditation for 5 years in Tier-II by National Board of Accreditation.

2. National Board of Accreditation has decided that in all cases where UG Pharmacy program(s) of an Institution were granted accreditation for a period of 5 years in Tier-I/II format, the period of accreditation of these program(s) shall be extended from 5 to 6 years subject to the condition that they meet the Pre-qualifiers for extension of duration of accreditation from 5 years to 6 years. The Pre-qualifiers submitted by **SVKM's Dr. Bhanuben Nanavati College of Pharmacy, Gate No.1, Mithibai College Building Campus, First Floor, V.M. Road, Vile Parle (West), Mumbai-400 056** in respect of the following UG Pharmacy program for extension of duration of accreditation from 5 years to 6 years have been considered. The program meets all the parameters of pre-qualifiers. Accordingly, the competent authority in NBA has approved the following accreditation status to the program as given in the Table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **SVKM's Dr. Bhanuben Nanavati College of Pharmacy, Gate No.1, Mithibai College Building Campus, First Floor, V.M. Road, Vile Parle (West), Mumbai-400 056** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of program(s) and the period of validity of accreditation, as well as the Academic Year from which the accreditation is effective should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

If there are any changes in the status (major changes of faculty strength, organizational structure etc.), the same are required to be communicated to the NBA, with an appropriate explanatory note.
